In response to your Invitation to Bid, the Bidders herein acknowledges that this Bid Proposal has been prepared and submitted subject to the conditions and requirements set forth by Specifications and other applicable Contract documents, including all Addenda. All of the aforementioned documents, so far as they relate to this Bid Proposal, are made a part hereof. The undersigned (CONTRACTOR) herewith proposes to construct the work stipulated on a per job basis for the unit prices given by the Bid Form that is part hereof.
9. The bidder is to coordinate the delivery and/or pickup of materials and provide all labor, supervision, and equipment required to complete the work as outlined, including traffic control and cleanup.
10. The undersigned Bidder has carefully examined the Contract Documents, and is familiar with the nature and extend of the work specified and any local conditions that may in any manner affect the work done, and the equipment, materials and labor required.

The undersigned agrees to furnish and install all materials called for by said drawings and specifications for each project, in the manner prescribed therein, in accordance with the contract documents and to the standards of quality and performance established by the owner, for the unit prices stated in the bid schedule. 12. To do any extra work not covered by the above schedule of prices, which may be ordered by the Engineer upon authorization by the City Council, and to accept, as full compensation thereof, such prices as may be agreed upon in writing by the Engineer and the Contractor.
13. To begin work within **fifteen (15)** calendar days from the date of receipt by him/her of Notice to Proceed or otherwise stated and to complete the work as agreed upon in the Contract Documents after the date of Notice to Proceed.
14. The undersigned Bidder certifies that this Proposal is made in good faith without collusion or connections with any other person or persons bidding on the work.
15. The undersigned Bidder states that this Proposal is made in conformity with the Contract Documents, and agrees that in case of any discrepancy or differences between any condition of his Proposal and those of the Contract Documents, the provisions of the latter shall prevail.
