**ORDINANCE
NO. 2018-09**

AN ORDINANCE OF THE CITY OF FELLSMERE, INDIAN RIVER COUNTY, FLORIDA, ADOPTING AN AMENDMENT TO THE ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2018 AND ENDING SEPTEMBER 30, 2019; APPROPRIATING FUNDS FOR THE ANTICIPATED RECEIPT OF TWO GRANT FUNDS (FURTHER DESCRIBED BELOW) IN THE APPROPRIATE FISCAL YEAR; AUTHORIZING THE TRANSFER OF FUNDS HEREIN APPROPRIATED SO LONG AS THE TOTAL COMBINED APPROPRIATIONS SHALL NOT BE INCREASED THEREBY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, THE City Council of the City of Fellsmere duly approved the application for the two below listed grant funds in the current fiscal year, in accordance with 166.241(3)(c) F.S.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FELLSMERE, INDIAN RIVER COUNTY, FLORIDA, as follows:

SECTION I: Approve the appropriation of funds for the FRDAP Senior League Lighting Improvements Grant,

Revenues:

117-00-00-334700 \$ 50,000.00 State Grant – Culture & Recreation

Expenditures:

117-00-00-572313 \$ 50,000.00 Consultant

SECTION II: Approve the appropriation of funds for the FRDAP Little League Lighting Improvements Grant,

Revenues:

134-00-00-334700 \$ 50,000.00 State Grant – Culture & Recreation

Expenditures:

134-00-00-572313 \$ 50,000.00 Consultant

SECTION III: The funds and moneys necessary to meet the appropriations stipulated by and in said budget are hereby expressly appropriated out of the anticipated revenues not otherwise appropriated.

SECTION IV: The Director of Finance and Accounting is hereby authorized and directed to increase the corresponding line item appropriations in the budget previously adopted to reflect the above budget amendments.

SECTION V: The Director of Finance and Accounting with concurrence of the City Manager shall have the authority to transfer appropriations from one account to another account of the budget, so long as the total appropriation of each cost center, including the Capital Outlay accounts related thereto, shall not be increased thereby. Appropriation transactions affecting any fund total, other than those authorized herein shall require the prior approval of the City Council. Any such transactions are subject to any restrictive statutes or ordinances, including those authorizing the issuance of any outstanding bonds.

SECTION VI: The Ordinance shall take effect immediately upon its adoption.

The foregoing Ordinance was moved for adoption by Council Member Savage. The motion was seconded by Council Member Herrera and, upon being put to a vote, the vote was as follows:
