

Indian River County Residents DID YOU KNOW?

- > The County provides residential curbside recycling collection for our residents.
- > Recycling services are included and paid through your Solid Waste Assessment. Therefore, with or without garbage service, recycling is picked up curbside at no additional cost to you. Indian River County would like to encourage our Residents to Recycle.
- > As an alternative to curbside residential collection, you may use any of the five convenience centers without charge where you can drop off trash, yard waste, recyclables and "sharps".
- > The convenience centers are for residential use only. No businesses please, except recyclables.
- > If you would like to subscribe to residential collection service, for garbage and yard trash and you live south of the Vero Beach City Limits or in Indian River Shores please call Treasure Coast Refuse at 562-6620.
- > If you reside elsewhere in the county, please call Waste Management at 569-1776 to subscribe.
- > Even if you decide not to subscribe for residential garbage collection, you may put out recyclables curbside for collection and you won't receive a bill for this service.

The ReUse Exchange Center accepts materials that can be reused by the public. Please telephone Keep Indian River Beautiful at 388-KIRB (5472) for more information.

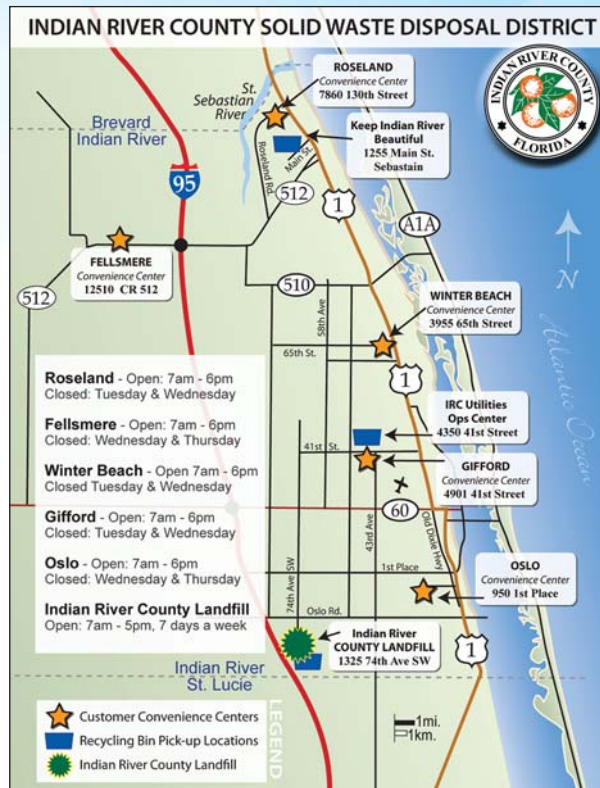


CONVENIENCE CENTER LOCATIONS

The Refuse Department provides five (5) community Convenience Centers. The centers are manned by S.W.D.D. personnel and are strategically located throughout the county to provide accessible collection points for all Indian River County households.

Residents can drop off their household solid waste, household hazardous waste, and additional recyclable items for transportation to the landfill facility by S.W.D.D. staff and equipment.

Commercial waste is not accepted at these facilities All sites are Closed Christmas Day, New year's Day, Labor Day, 4th of July and Thanksgiving Day.

CURBSIDE RECYCLING

Items placed in blue bins may also be taken to Convenience Centers and the Landfill

Bin 1

- Plastic Containers #1-7
- Glass Containers (Brown, Clear & Green)
- Aluminum Cans, Aluminum Foil, Pie Plates & Trays
- Steel Cans
- Aerosol Cans (No Household Hazardous Waste)
- Aseptic Packaging (Juice & Milk Cartons)

Bin 2

- Newspaper & Inserts
- Phone Books
- Envelopes/Junk Mail
- Office Paper
- Shredded Paper (Place in Clear Plastic Bag)
- Catalogs / Magazines
- Brown Paper Bags
- Other Paper Products (Cereal/Food Boxes, Pizza Boxes, Soda, & Beer Boxes)
- Corrugated Cardboard (Flat- No larger than 2'x3')



Residential Curbside Recycling is provided by the county. Every registered household address will receive two blue bins. If moving or renting, the bins should stay with the address they are registered to.

CONVENIENCE CENTERS & LANDFILL

No-Charge items accepted at Landfill and Convenience Centers

- RESIDENTIAL HOUSEHOLD GARBAGE: Includes household garbage, recyclables, normal yard waste (under 3 inch diameter and 4 feet long), and some household hazardous materials.
- WHITE GOODS/LARGE APPLIANCES: Stove, Refrigerator, Washer, Dryer, Dishwasher, etc.
- TIRES: Small Auto ONLY (Limit 2)
- BATTERIES: Household & Automobile
- SCRAP METAL: Steel, Iron & Aluminum
- USED MOTOR OIL: Filters & Antifreeze
- PAINT CANS: Not to exceed 5 gallons
- SHARPS: In closed containers
- FLUORESCENT LIGHT BULBS
- STYROFOAM RECYCLING: For all white expanded polystyrene/styrofoam(EPS) is also accepted. Items that are included: Styrofoam packing (from computers, furniture, appliances, and other white dimensional EPS) and unused hot/cold cups.

Not Acceptable: contaminated foam trays or carryout containers. Remove all plastic bags, tape, and/or labels from the EPS. Packing "peanuts" can be taken to KIRB, Pak Mail or The UPS Store for reuse.

Loads over 100 cubic feet are not accepted at the convenience centers due to limited space. Please Rinse Containers. No caps on Containers

LANDFILL ONLY

The function of the Sanitary Landfill is to provide effective waste reduction, reuse, special waste processing, and waste disposal services necessary to maintain the health, safety and well being of all residents and the environment. The Sanitary Landfill operates in strict compliance with State and Federal permit requirements. Operations at this facility include: Contracted Class 1 landfill disposal operation, yard waste reduction, recycling, waste tires recycling, household hazardous waste services, construction and demolition debris recycling and disposal, environmental compliance and site management.

Chargeable Items Accepted at Landfill

These items must be taken to the Landfill and not to the Convenience Centers:

- Land Clearing Debris.....\$22.00 Ton (exceeding 3 inches in diameter and 4 feet in length)
- Construction & Demolition\$31.80 Ton
- Heavy Equipment Tires.....\$20.00 each
- Automobile Tires (4-max).....\$2.00 each
- Animals (+100 lbs.).....\$50.00 each
- Animals (-100 lbs.).....\$5.00 each

\$ 3.00 Minimum on Chargeable Items

How fees are calculated for Landfill on accepted and chargeable Items

Upon entering the landfill you will weigh in on the in-bound scale. The scale operator verifies your load contents and directs you to the proper disposal area. After unloading you will weigh out on the out-bound scale and receive a weigh ticket totaling your fee. All Loads must be covered, or you will be charged \$25.00 per incident.

The landfill accepts personal checks or credit cards (Visa, Mastercard, and Discover) with proper I.D. Businesses may open a check or charge account.
